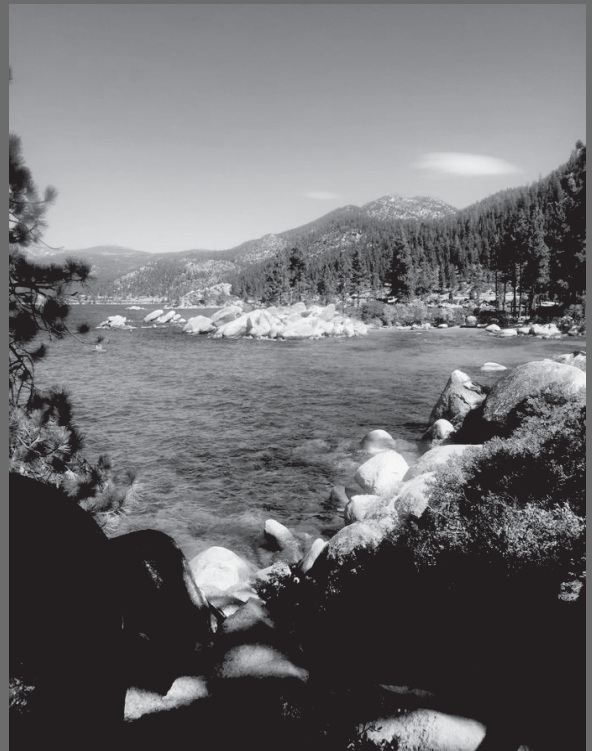

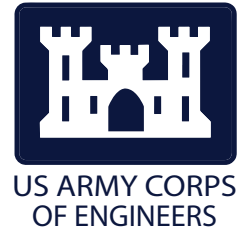

ENVIRONMENTAL COMPLIANCE

- Stormwater and Wastewater Permit Compliance (Multiple Sites and States)

Odyssey provided water permitting compliance services, including preparation of permit application packages for general and individual National Pollutant Discharge Elimination System (NPDES) water discharge permits, water quality monitoring sampling, discharge monitoring reporting, best management practices (BMPs) selection and inspection, and Stormwater Pollution Prevention Plan (SWPPP) preparation.

- Linear Transportation and Industrial Site Construction Stormwater Permitting and SWPPP Development (Multiple Sites - Louisiana)

Provided construction stormwater support for a new road construction project in Monroe, Louisiana. Scope of work included preparation of a SWPPP for construction activities and subsequent preparation/submittal of the Notice of Intent (NOI) for coverage under the LDEQ Stormwater General Permit Associated with Construction Activity Greater than 5 Acres (LAR100000). In addition to permit application and SWPPP development, Odyssey supported the inspection, recordkeeping, and compliance management components of the SWPPP for an industrial site in Hodge, Louisiana.

- Environmental Facility Assessments/Audits (Multiple Sites)

Performed multimedia compliance audits for a variety of industries. Audited media included stormwater, wastewater, air, solid waste, universal waste, hazardous waste, hazardous materials, required annual reporting, and Spill Prevention Control, and Countermeasures (SPCC). The regulatory jurisdictions audited were federal, state, and local laws.

- EHS Program Management (Multiple Sites)

Odyssey provided broad-scale multimedia EHS compliance support for a variety of industries. Onsite support included required inspections, water sampling/monitoring, environmental compliance file management, formal and informal employee training, waste profiling, consultation with site management, and strategic planning support. Supplemental remote support included completion of air, water, and waste reporting and development and updating of operational compliance plans.

Provided SPCC support both for initial/new plan generation and for various levels of plan updates. Also provided strategic planning support for successful navigation of SPCC requirements on a site-specific basis.

Scope of work for this HUD-funded residential development project consisted of the completion of an EA and a Phase I environmental site assessment (ESA) to satisfy the HUD environmental review requirements.
- Phase I Environmental Assessments (Monroe, Natchitoches, Bastrop, Winnfield, Dodson, West Monroe, Chatham, Ruston, Louisiana)
Odyssey completed the American Society for Testing and Materials (ASTM)-compliant Phase I ESAs for a variety of clientele and property types for transactional purposes and also for procurement of regulatory funding.
- EPCRA 311 and 312 Reporting (Monroe, West Monroe, Ruston, Bossier City, Louisiana)
Odyssey prepared one-time and annual reporting as required by the Emergency Planning and Community Right-to-Know Act (EPCRA), Sections 311 and 312 (also known as Tier II Reporting) for a variety of facility types.

Odyssey conducted required environmental training for employees across multiple industries. Scope of work included the generation of training materials, delivery of training materials in a classroom-type setting, and management of required training documentation for the client.
